The purpose of this exhibition is to provide an arena for ART Station member artists to exhibit and sell their fine art. The juror fee is \$5 per piece for applications submitted by **Saturday, June 17<sup>th</sup>, 2017**, (applications and submissions will be accepted through **Saturday, June 24<sup>th</sup>, 2017**; however, juror fee after June 17<sup>th</sup>, is \$10 per piece). ART Station membership must be current.

**Artists may submit a maximum of 2 original pieces** of fine art in any medium (no clothing or jewelry, please). Work cannot have been exhibited previously at ART Station and must have been **completed in the last 2 years, not under instruction in a class or workshop**. Work must be original in subject and execution: mechanically reproduced artwork is not accepted. Two-dimensional work must not exceed 6' x 6' and may not be smaller than 8.5 x 11" framed. **All paintings must be ready for hanging, with wire in place, in an appropriate gallery frame and identified on back with title and artist's name. We strongly encourage the use of white or off white top matting.** No sawtooth hangers will be accepted. Glass will be accepted only on pastels (per insurance guidelines). Three-dimensional work must not exceed 6' in any direction, and any component must not weigh over 150 lbs. Works do not have to be for sale, but ART Station will encourage sales of works that are offered for purchase. ART Station will receive a 30% donation of sales from the artist.

Artists will be notified of works accepted by Thursday, July 6<sup>th</sup>. **All are encouraged to attend the opening reception for this exhibition on Saturday, July 8<sup>th</sup> from 6 – 8:00 p.m.** Cash prizes will be awarded at that time. The exhibition will continue through September 18<sup>th</sup>, 2017 and all works must remain on view throughout the exhibition. After the exhibition closes all work should be picked up by September 23<sup>rd</sup>, 2017.
